MACSP Advocacy Day

May 16th , 9am-12pm

Once again, the Hall of Flags at the State Capitol Building will be adorned with artwork from agencies across the state during the MACSP Advocacy Day. "Lest we Forget 2023" will be paired with the I/DD Advocacy Day to draw attention to individuals with disabilities whose voices are heard through their artwork, and the agencies who support them.

MACSP members are invited to submit **one** piece of art from their agency that highlights the contribution that artists with disabilities can make to the greater art community. **Due to the short notice, and limited space, submissions will be limited to a maximum of 20 pieces.** Submissions must be from programs serving children or adults, with intellectual and developmental disabilities or autism.

The following art media will be considered:

Painting/drawing Photography Small sculpture Fiber/textile work/Jewelry

There are four portions to your initial submission, which are due no later than May 12, 2023.

- 1. There will be no entry fee for participation this year.**
- 2. Entry form** (emailed fillable form, or mail in hand written form)*
The Attached entry form should be filled out **entirely**.
- 3. Digital agency logo** (by email bbraley@iaofmaine.org)
- 4. GOOD quality digital image** of the artist. **PLEASE** no quick phone pictures. The image needs to be crisp and able to be reproduced at a 4 x 6 print size. (please do not send prints via mail.)

*if the artist wants to fill in the entry form by hand, you may mail it but all info must be complete, and it must be legible, and arrive by **May 12th**. The sooner you complete the application the better. **Only the first 20 entrants will be allowed to enter "Lest We Forget 2023".**
